#### **Applicant Eligibility:**

- 1. Applicant should be a graduating high school senior entering an accredited college or university as a full-time student, pursuing their undergraduate degree with a minimum of 12 credits per semester, beginning September 2018, or a student who is currently full-time at an accredited college or university with a minimum of 12 credits per semester, beginning, September 2018.
- 2. Applicant must be an employee, employee's dependent, or dependent grandchild of a BCA/SJ Associate Member.
- 3. It is the intention of the **BCAJ** that a four-year scholarship in amounts up to \$1,000.00 per year will be awarded and checks will be made directly to the institution providing education. Successful student must maintain a "2.5" average their 1<sup>st</sup> year, "2.8" average their second year, and "3.0" average their 3<sup>rd</sup> & 4<sup>th</sup> year, as evidenced by a formal transcript to maintain scholarship eligibility.

#### **Employee Eligibility:** (parent, guardian, grandparent of the applicant)

- 1. Employee must have worked for a BCA/SJ Member for at least 800 hours within the last 12 months.
- 2. A letter, on employer stationery, from the employee firm's principal verifying the 800 required hours of employment.

- 1. Completed application form with signature.
- 2. Letter of recommendation completed by Academic Advisor on official letterhead.
- 3. Official Grade Transcript and official SAT scores (if not displayed on transcript)
